I'm an employee. I use engagement letters in the division that I manage, however, I also prepare taxes for my employer's clients and at the moment she is not enforcing the engagement letters. How will that affect me if I'm the tax preparer of those business/individual tax returns? Should I be sending an engagement letter if I'm preparing that tax return even if it's technically not my customer?	From your scenario, I would recommend the engagement letters to your employer. It might be a matter of you preparing the forms and having the employer's clients sign them when they send in tax documents for the return preparation
How soon after the engagemnet is completed should the POA be revoked?	Generally, we withdraw the POA around 30 days after the case is completed. We consider the case completed once our resolution posts in the clients file or we recieve a letter that the IRS has finalized the resolution we requested

And had the client respond with "I agree", which served as their signature. In your opinion, would these agreements hold up?	I would recommend that they physically sign a document and send it back. A signature is harder to dispute than someone typing in the words "I agree" if an issue arises.

How can I find out what POA's the IRS has from me on file for client's of various CPA firms that I worked for?	You can do a FOIA request of your CAF file. The IRS can send you a list of all the 2848s and 8821s they have on file for you
can you withdraw your 2848 for a year that is not in the engagement letter for which the IRS believes you are to be representing them	You can withdraw the 2848 and submit a new one.
Can you change the 2848 for fewer years after covering more years previously	You can withdraw the old one and file a new one.
Would I need a lawyer to edit these engagemnt letters? Could I expect to be reasonably protected if I drafted these letter competely on my own? (assuming they're legal, of course)	You do not need an attorney for engagement letters. You must just clearly outline the scope of what you are doing for the client and what you expect of the client (ex: for preparation - that the client is providing all records necessary to prepare the return and will not hold you responsible for any errors or omissions if items were not provided)
Regarding signatures on an engagement, I have typically only had the client(s) sign the engagement. Should I as the service provider and party to the engagement also sign to create a bona fide contract, or is the clients' signature sufficient?	You should be signing the engagement letters as well. That helps create the contract aspect. You are both signing in agreement of the terms
